COMMITTEE REPORTS:

<u>Community Relations</u>; <u>Rogue River Chamber of Commerce</u>: Mayor Wayne Stuart reported that they had discussed the new city tourist map, improvements to the Winter Wonderland decorations and the upcoming Chamber Mixers' for 2020.

<u>Community Relations</u>; <u>Rogue River Community Center</u>: City Councilor Barb Hilty reported they heard a financial report from Edward Jones representative Brian Dorsey, accepted a resignation from their Director Sue Smith effective June 30, 2020, also accepted a resignation from Shawna who worked in the kitchen effective

February 29, 2020. And, Access would continue to provide homebound meal deliveries.

Emergency Communications of Southern Oregon: Mayor Wayne Stuart reported that they approved their budget and that they were going to bid for the upgrades to the dispatch center.

<u>Finance Committee</u>: City Councilor Don Daugherty reported that they met twice during the month of January 2020 to review and approve the bills submitted for payment. They signed 72-checks totaling \$191,131.86 for the month.

Middle Rogue Metropolitan Planning Organization (MRMPO): City Councilor Pam VanArsdale reported that she had been elected as Vice Chair for the MRMPO and they had reviewed projects through 2024, 2035 and 2045. She was pleased to see that the Oregon Department of Transportation was looking at taking on Rogue River's projects in the amount of \$6-million dollars.

<u>Police Commission</u>: City Councilor Fred England reported that he felt very fortunate that the department was doing well, they were continuing with training opportunities and their new body cameras were working out well.

City Councilor Don Daugherty commented that Chief Curtis Whipple had held their Coffee with a Cop meeting along with Corporal Buren and Patrol Officer Gomez.

Rogue Valley Council or Governments (RVCOG): Mayor Wayne Stuart reported that they were having difficulties having a quorum and discussed the jurisdictions assigning alternates to attend their meetings. They were looking for assistance for building upgrades during earthquakes but did not get anywhere so they would be staying with the duck under the table scenario and hope that no one would be harmed. They also had a presentation from the Jackson County Community Justice System who explained a new method of dealing with low crime criminals going to a supervised half way house or left in the possession of their probation officers. And they also had work programs allowing them to work off their time.

City Councilor Fred England asked what they considered low crimes.

Chief Curtis Whipple commented they would be drug crimes and thefts.
